GUIDELINES ON THE USE OF ADDITIONAL TUG BOAT DURING SPRING TIDE

I would like to refer to the above matter of which LPK Notice No. 3/2004 dated 24 October 2004 is also related.

2. Please be informed that with effect from the date of this letter, all berthing and unberthing movements of ships of **LOA between 250 meters and 300 meters are required to utilise three tugs during Spring Tides**. The terminal will raise charges for the additional tug service in accordance to the rates approved under the Port Klang Authority (Scale of Rates, Dues and Charges) By Laws 2012.

3. Accordingly, LPK notice, No. 3/2004 dated 24/10/2004 on The Guidelines regarding the use of Tugs is amended as follows:

i. **LOA of vessel below 140 meters - 1 tug**

ii. **LOA of vessel 140 meters and above but below 300 meters - 2 tugs**

iii. **LOA of vessel 300 meters and above - 3 tugs**

iv. **LOA of vessel between 250 meters and 300 meters during Spring tide - 3 tugs**

4. The use of additional tugs other than those stipulated above shall be at the discretion of the pilot after due consultation with the Master of the ship.
